MEETINGS

There were no meetings held in September.

BUILDING MAINTENANCE

- Maintenance performed the following:
 - Hurricane Dorian Storm cleanup
 - - Return all patio furniture and power wash all furniture
 - - Clean up debris from property and in pools
 - - Clean out all basement drains from storm
 - - Clean filters from storm debris
 - - Coordinate solar panel check from storm
 - Work with Coleman Plumbing to locate sewer pipes
 - Replaced four (4) turtle lights
 - Replaced two (2) broken deck lights
 - Repaired sump pump south pool
 - Washed down all walkways
 - Back washed north and south pools
 - Scum lines north and south pools
 - Performed weekly and monthly maintenance tasks (maintain and keep clean the pools, laundry rooms, storage rooms, bike rooms, tennis courts, stairs, walkways, handrails, door locks, bathrooms and recreation room)
- Vendors/Contractors performed the following:
 - Coleman Plumbing – Completed sewer line project pipe installation all of B and E buildings. Replaced broken water line pipe B building.

GROUNDS:

- Terra Scape – Cut down and hauled away a palm tree that fell during the storm; repaired ¼" main sprinkler line, replaced 4 defective rotor sprinklers, 4" popup sprinkler and installed 3 risers. Replaced defective remote control timer.

MANAGER'S NOTES

- A special assessment in the amount of \$600 due from all owners of record for the purpose of locating and replacing all exterior sewer cleanout pipes was approved at the Board of Director's Special Assessment Meeting held on August 31, 2019. The special assessment in the amount of \$600 will be due and payable on November 1, 2019 with a late fee of \$25 if received after November 15, 2019.
- SEWER PIPE PROJECT UPDATE: Coleman Plumbing has completed all sewer line pipe replacement and installed popups on all units in the B and the E buildings and have partially completed the D building.
- Hurricane Season is June 1 – November 30. During Hurricane Season please bring in all items from your patios, including your patio furniture, when you are not here. This will help Ray and I when we are preparing for a storm.
- Sea turtle nesting season is May 1st through October 31st. Lights adjacent to the beach MUST NOT BE VISABLE FROM THE BEACH. Please help us protect the turtles and comply with local lighting regulations. The regulations are strictly enforced by fines for violations. Keep balcony and porch lights turned off during the nesting season. Also, draw your drapes or blinds at night if your room is lighted. These few simple steps will greatly increase the chance that baby turtles will safely reach the ocean this summer and keep us in COMPLIANCE. Thank you for your understanding and cooperation.
- REMINDER: THE 2019 MAINTENANCE DUES ARE \$495. PLEASE MAKE THAT ADJUSTMENT.
